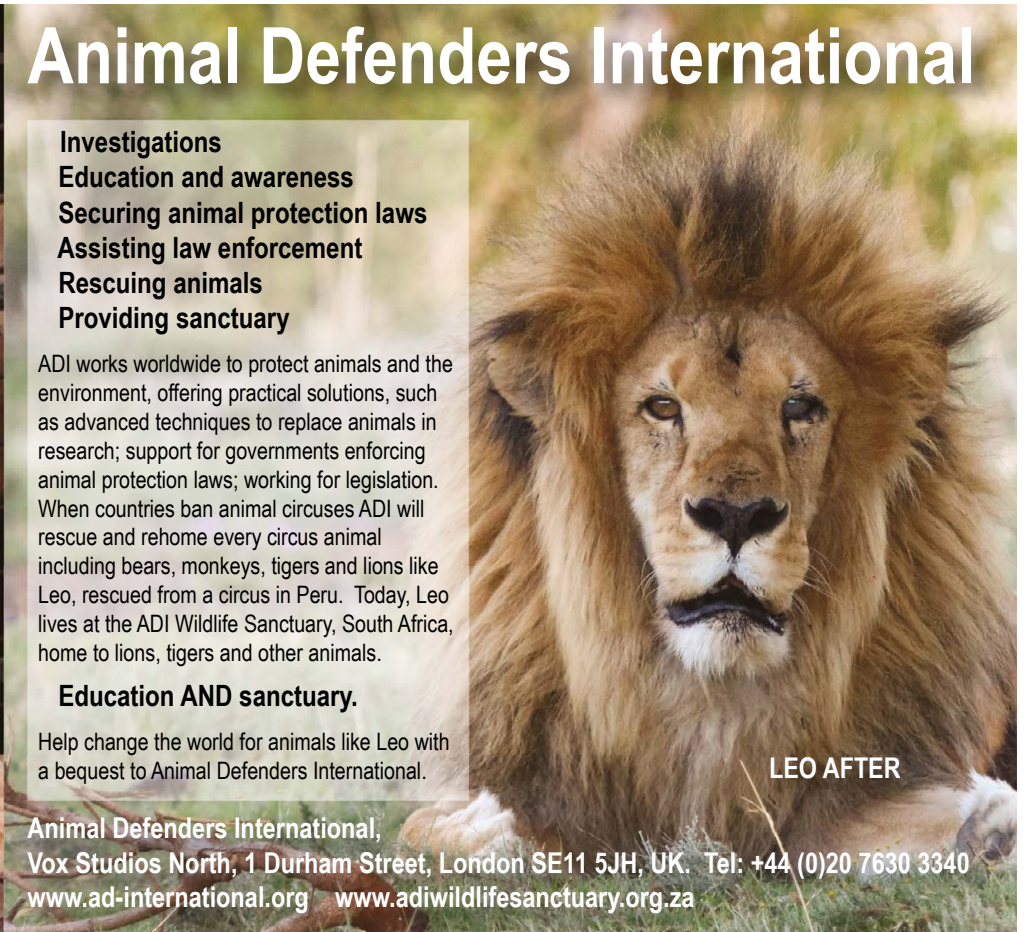

The power of shared legal knowledge

The International Law Book Facility's mission is to share legal knowledge – since it was founded in 2005 by Lord Thomas of Cwmgiedd, former Lord Chief Justice of England and Wales, the ILBF has shipped 88,000 books to 280 organisations in 57 countries. Books are donated by law students, lawyers, law firms, barristers' chambers, courts and legal publishers; teams of volunteers sort and pack books ready for shipment by sea freight.

The ILBF's mission is as critical as ever with legal institutions across the world under extreme pressure from lack of resources. The ILBF relies entirely on funding from individuals, law firms, barristers' chambers, and foundations to pay for shipments.

You might ask why books are still in demand, and in particular law books from the UK? The answer lies in the relevance and standing of English law in many countries, the perennial issue of unreliable internet access, as well as the cost of online subscriptions, and the continued popularity of printed texts for research, especially for the judiciary and for law students. Scores of legal systems around the world were founded on the common law, a contentious but factual legacy of the colonial era. Legal resources from the UK are therefore relevant and citable in many jurisdictions. Nasar Danmallam, Attorney General and Commissioner for Justice in Niger State, Nigeria said on receipt of Halsbury's Laws and Halsbury's Statutes, "these are very authoritative books in terms of legal commentary on practically every area of law".

Legal resources from the UK also offer a point of comparison for legal systems which are based on a different tradition. When it comes to drafting legislation, legislators will often review how other jurisdictions have tackled complex issues such as financial and banking laws, technology, intellectual property, digital rights and much more.

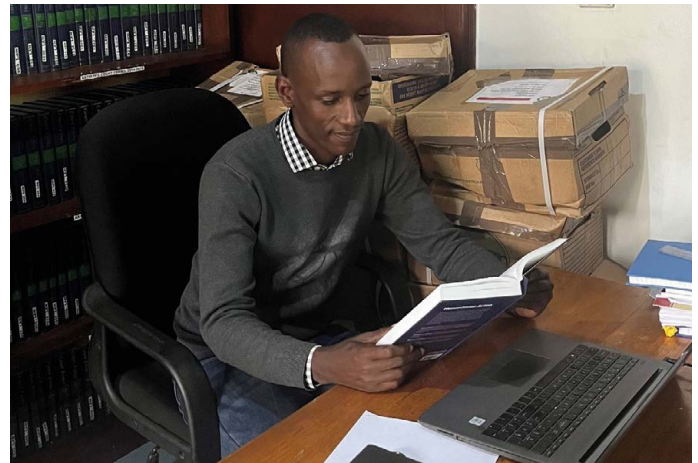
Books from the ILBF therefore support education, legal consistency, authority, and fairness in the legal system. The impact of the books spreads through whole communities to help strengthen, widen and deepen access to justice and the rule of law.

Repurposing printed texts also helps to drive sustainability in the legal sector by saving valuable books from landfill; using sea freight minimises the ILBF's carbon footprint. The ILBF partners with multiple organisations in the UK to further rule of law programmes.

A partnership with the UK Sierra Leone Pro Bono Network (UKSLPBN) over the last eight years has delivered over 6,000 books in support of the UKSLPBN's pioneering work in Sierra Leone with the judiciary, the legal profession, law schools and universities. The most recent initiative with the UKSLPBN is to ship books on advocacy to support an advocacy training programme by the Inns of Court College of Advocacy International Committee and the Sierra Leone Bar Association. Textbooks on advocacy will be an invaluable complement to the training and help to enhance its impact and long-term sustainability.

Another example of partnership is with Justice Defenders. Books from the ILBF line the shelves of prison libraries in Uganda and provide invaluable resources for prisoners and prison officers who are studying for their legal diplomas and LLBs with the University of London. Whole communities benefit from the legal education they undertake, especially now that Justice Defenders has opened its first out of prison legal office in Kenya.

Canaan Nkamuhabwa, a graduate of the University of London Under Justice Defenders' Scholarship programme, now works as a legal trainee attached to one of the prison-based legal aid offices, says "I use these books as a research source for drafting written submissions for our clients and I wonder how my work would have been without them".

The Trust was set up in 1994 by people with diabetes for people with diabetes. We offer support and understanding to those with diabetes and their families. We provide a free telephone listening service and information leaflets to enable people with diabetes to have an informed choice of treatment and to help with the day to day difficulties of living with diabetes.

Around three quarters of a million people in the UK have insulin requiring diabetes and the incidence of diabetes in children is increasing. It is essential that we support research to help this very vulnerable group faced with a lifetime of diabetes. Your support will enable us to further develop our programme to help children and provide information for teachers about the needs of children with diabetes.

Diabetes can cause blindness, kidney failure, nerve damage and heart attack that severely affect the lives of all those living with diabetes. A cure for diabetes is still illusive so the Trust supports research that will help to improve the daily lives of people living with diabetes now. The studies we support involve people with diabetes under normal treatment conditions to ensure that it reflects 'real life' conditions. We also collate information from the experiences of people with diabetes to help to inform others.

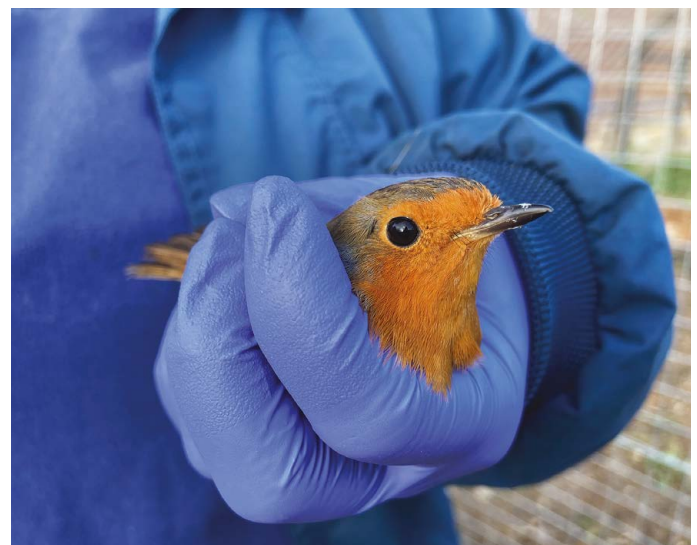
Here at Tiggywinkles, we are dedicated to rescuing and rehabilitating British wildlife. We are open 24hrs a day, 7 days a week to help any wild animal in need and our service is free of charge. We rely on donations to provide our life-saving care for patients like



Robbie the robin, who arrived in our care under unusual circumstances!

As the World’s leading teaching wildlife hospital, we have lots of students on site and one of our Level Two Animal Care students found Robbie on the pathway of our grounds. She immediately realised he needed help as he was lying flat and couldn’t fly. She rushed him into triage and our duty nurse quickly assessed his condition.

Sadly, Robbie was suffering from temporary ataxia – the loss of coordination and control of movement – and the team suspected he had sustained head trauma. To treat his symptoms, our vet put Robbie on a short course of antibiotics and pain relief. After one week of treatment, Robbie was once again flying around his cage and was ready for release.



We are so happy that we could help this beautiful bird back to the wild and although we never want any wild animal to find itself in trouble, it is nice to think that they know where to come, should they ever need help! Our doors are always open to any wild animal in need, even walk-ins!
